4	Page 44	Power Source – Tender asks for "AC Power 220V (+/-10%) & 50Hz (+/-1%), 100 Watts or better 90% power efficient, EPEAT certified " it is firstly important to note that EPEAT is a standard followed for countries other than India and not in India as Govt of India has so far not come out a poilcy related with EPEAT. Secondly – EPEAT standard is largely based on 80Plus standards for Power Supplies to decide on the EPEAT certification level thus it is observed that instead of asking for 80Plus Certification for Power Supply tender has asked for EPEAT. We hereby request you to please amend the clause and kindly take in to consideration the native certification i.e – 80 Plus Certification	No change in specification
5	Page 44	ISV Certification – Tender asks for "ISV Certification" for certain applications with Workstation. It is important to note that in various cases it is observed and notified by Central Govt bodies including DGS&D that such ISV certification hold no value as these certifications are fundamentally based on the configuration of x86 architecture based workstation and the Graphics card selected. That is the only reason latest DGS&D Workstation rate Contract was released with tis clause removed from the RC and instead of ISV certification it was mentioned as OEM Certification as it is only about compatibility of workstation and the application. Thus we hereby request you to please amend the clause ISV certification as "OEM Certification"	No change in specification
