Annexure-V , Price Bid	To how many decimal places can the service charge be quoted	It has clearly been depicted and mentioned in the Price Format/Schedule that service charge quoted has to be rounded off to only two decimal places. For eg. If A bidder quotes a service charge of 05.562% against , say, manpower component, it will be treated as 05.56%.
