Buyer Added Bid Specific Additional Terms and Conditions

- Bidder shall submit the following documents along with their bid for Vendor Code Creation:
 - Copy of PAN Card.
 - Copy of GSTIN.
 - Copy of Cancelled Cheque.
 - Copy of EFT Mandate duly certified by Bank.
- For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:
 - Purchase Order copy along with Invoice(s) with self-certification by the bidder that supplies against the invoices have been executed.
 - Execution certificate by client with order value.
 - Any other document in support of order execution like Third Party Inspection release note, etc.
- Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.
- Buyer Added text based ATC clauses
 - Bidder, if required, may visit the site for inspection on his own expenses.
 - Contractor shall depute experienced technical supervisor to supervise the assigned work under the contract.
 - All employees of the contractor must carry his valid identity card while visiting locations for carrying out the job.
 - The contractor will provide the PPE viz: helmets, goggles, hand gloves and safety shoes etc. to the persons deputed for the job.
 - Contractor's personnel should strictly adhere to all the Safety Norms. Contractor shall provide all tools, tackles and machineries required for completion of work.
 - The Contractor shall procure/ supply of all the requisite materials in order to finish/ complete the work as per scope of work.
 - The Contractor's personnel should follow good engineering practices all the time.
 - Warranty: 60 days' warranty for the workmanship and spare parts/ consumables used.
 - Duration of contract: 45 days from the date of award of contract.
 - Contractor has to mobilize their resources within a week to commence the work.
 - Time Schedule: The work should be completed within 21 days from the date of commencement of work.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid.
