OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Buyer Added Bid Specific ATC

#### **1. Bidder-Prequalification criteria :**

**Bids must comply to the bidder(s) pre-qualification criteria as detailed under Annexure-II (Buyer added ATC document) . Bidder must submit all supporting documents as sought for under Annexure-II, failing which the bids shall be straightway rejected.**

#### **2. Payment Schedule**

(i) DGH will release 70 % payment on delivery of supplied hardware, software after acceptance of delivery by DGH as per the terms and conditions of the supply order.

(ii) The remaining 20% payment will be released after a) successful completion of installation, commissioning, configuration and training b) completion of the one week testing period after installation date as per the scope of work above & c) submission of all relevant documents specified under "Documentation".
