If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 2. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase

preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.

3. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Bidder must submit bid security declaration. Bid security declaration shall be submitted as below:

"We hereby accept that if we withdraw or modify our bid during the period of validity, or if we are awarded the contract and we fail to sign the contract, or to submit a performance security before the deadline defined in the bid, we will be suspended for a period of 02 years from the date of suspension."

The above declaration should be submitted at bidder's letterhead mentioning bid number/ details in refere nce and signed by authorized signatory.

2. Eligibility Criteria:

a) Eligibility criteria for bidding firm is as under:

- (i) The bidding firm must be a CA firm registered in India.
- (ii) The bidding CA firm should have been in existence for 5 years or more as on Bid Closing date.
- * Bidders must furnish documentary evidence along with their bid in support of fulfilling above requirement of eligibility criterion failing which the bids are liable to rejection.

b) Qualifications and Experiences of Candidates:

The educational qualification, minimum required skillset and experiences required for the post of Consulta nt through CA firm is as under:

- (i) Candidates must be a qualified Chartered Accountant.
- (ii) Candidate should be below 45 years of age.
- (iii) Candidate must have minimum 5 years of post-qualification experience either in practice or in full time service or combination of both. Cutoff date is date of submission of CV of the candidate. In case of experien ce in industry, candidate should have worked in a company having minimum annual turnover Rs. 50.00 Cr ores. In case of experience in a CA firm candidate should have the experience of statutory audit of a company having minimum annual turnover of Rs. 50.00 Crores.
- (iv) Candidate having 1-year post qualification experience in the E&P field/PSC audit would be preferred.
- (v) Candidate must have good working knowledge of MS-Office.
- * Resumes/CVs of suitable candidates meeting the above qualification /experience shall have to be forwarded by the successful CA firm post award of contract for screening/shortlisting by DGH, within seven (07) days of date of award of contract.

If felt necessary, shortlisted candidates may be called for personnel Interview by DGH team b efore final selection of candidates for the post of CF Consultants.

The selected candidates are required to be deployed at DGH office, within 07 days from the date of intimation of selection of the candidate by DGH.

3. The service contract would be initially valid for Two (02) years. The contract may be further extended by one more year at the same rates, terms, and conditions on mutual consent.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्ते</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
