### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

The Scope of work would include:

a. Supply of 230 licenses for MS 365 Business Standard with 1(one) year subs cription to Directorate General of Hydrocarbon, Sector 73, Noida.

b. The Office Software will include desktop versions of Office apps, viz. Outlook , Word, Excel, PowerPoint, OneNote, Microsoft Access, Publisher for PC & Micro soft Teams for virtual meetings.

c. 1 TB of OneDrive cloud storage will be available to each user.

d. Software updates/ patches released by Microsoft for the product during the subscription period must be provided to DGH unconditionally and free of cost.

e. Vendor will have to address all the issues related to M365 and share the RC A/SOP with DGH.

f. Any other service/ features added to the product by Microsoft during the su bscription period shall be delivered to DGH unconditionally and free of cost.

g. Delivery of licenses and admin configuration to be completed within 05 days after placement of order.
