1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Bidders are bound to accept the orders accordingly.

Total Bid Value (inclusive of GST) (C) must be entered against the "OFFER PRICE" field while creating their response against the tender in GeM portal.
- 4. In case a bidder is eligible to seek benefits under Public Procurement (Preference to Make in Indi a), Order 2017 as well as Public Procurement Policy for MSEs Order 2012, then the bidders sho uld categorically seek benefits against only one of the two policies.

### Disclaimer/अस्वीकरण

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
